#### CALL TO ORDER

Mr. Rose called the meeting to order at approximately 3:08 PM.

Mr. Washington moved, seconded by Mr. Livingston, to adopt the agenda as published. The vote in favor was unanimous.

#### ALVIN S. GLENN DROP-OFF

- Mr. Harley stated that the proposal is to go through the County's procurement process to secure a provider to transport the former detainees upon release from the Detention Center.
- Transportation costs are as follows: 65% - City of Columbia, 25% - Richland County and 10% - Other Agencies
- The voucher will be for a set amount. If the cost is more than the voucher the former detainee will be responsible for the additional cost. If the entire amount is not utilized, it will roll back into the County's account.
- Mr. Rose expressed his desire to ensure that the transportation vouchers are only provided to those that do not have a means of transportation and/or are indigent
- Mr. Washington moved to forward to Council without a recommendation. The motion died for lack of a second.
- Mr. Livingston moved, seconded by Mr. Rose, to proceed with issuing the RFQ. The vote in favor was unanimous.

#### BUCK COMPENSATION STUDY

- Mr. Hanna presented the committee with the cost comparison table for positions between ASGDC, Lexington County Detention Center and Richland County Sheriff's Department.
