Approval of Board Meeting Minutes

• The Board Members reviewed the minutes from February 24, 2014. A motion was made to approve the meeting minutes. Seconded. Approved 5-0.

Board Chair Comments

- Mr. Dowdy stated that in an effort to make the office more accountable to citizens, decisions had to be made. As a result, leadership and office staff were evaluated which resulted in a decision being made after careful consideration.
- The Board is committed to working towards regaining trust in the office and desires that all votes are counted and accountable for. To continue the stabilization and to move the office forward, the Board has decided to appoint Mr. Samuel Selph as Interim Director. Mr. Selph has been a poll manager at the Woodfield Precinct since 1984 and is a 40 year retiree of South Carolina State Government. Mr. Selph will serve in this capacity until someone capable can be found to lead the office. Mr. Selph, the newest Board Member, will manage the office on a day to day basis and will resign from the Board immediately to serve as Interim Director.
- Mr. Dowdy requested for Mr. Selph to read his resignation letter. Mr. Selph stated that the letter was addressed to the Delegation Chairman, Representative Joe Neal:

"This letter is to inform you and the other members of the Richland County Legislative Delegation of my resignation from the Richland County Elections and Voter Registration Commission, effective immediately. I am resigning at this time because the Board requested that I assume the directorship of that office, in an interim capacity. I have enjoyed my tenure with the Commission and trust that I can depend on your continued support. Again, my sincere thanks.

• A motion was made to accept Mr. Selph's resignation from the Board. Seconded. Approved 4 – 0.

Citizen Input

- Mr. Dowdy stated that the Board appreciates the community's involvement, but since that citizen input be held off until the next meeting.
- Mr. Robert Liming responded and indicated that the issues are far more pressing to put off until another meeting. Mr. Liming further stated that the Board was in receipt of a copy of a letter that was sent to Mr. Jackson regarding public confidence in the voting process. Mr. Liming stated that he was 1 of the 1100 citizens whose vote did not count during the November 2013 election. The public is calling for more openness and so far, there have not been answers regarding the individual(s)

• Mr. Dowdy thanked Mr. Liming for his comments.

- Ms. Elaine DuBose made a motion to appoint Mr. Samuel Selph to act as interim director for as long as it takes to find a new director. Seconded. Approved 3 1.
- Ms. Adel Adams requested that the Board Member's individual votes be recorded for the minutes:

- Ms. Selph responded that he is humbled by the Board's votes and has confidence that the office will move forward.
- Mr. Dowdy stated that he believes that the Board will work together as a team to move the office forward.
- Mr. Jim Carpenter requested to speak before the Board and stated that he is an
 attorney from Greenville, SC who represented the plaintiff in a court case that was
 brought against the Board regarding the Board's legality. According to the judge's
 ruling, the law that established the board and dis-established the two previous
 boards was ruled unconstitutional and that the Board is currently acting without the
 sanction of the law.
