Looking ahead on the calendar, November 11 is Veterans Day. Originally called Armistice Day to honor the armistice with Germany that took effect at "the 11th hour of the 11th day of the 11th month" in 1918, it effectively marked the end of World War I. In 1954, Armistice Day was changed to Veterans Day to honor and celebrate the service of all U.S. military veterans. Because Veterans Day honors all the men and women who have served, it differs from Memorial Day, which honors service members who have died in the military. According to the Veterans Day Moment of Silence Act, "The President shall issue a proclamation calling on the people of the United States to observe two minutes of silence on Veterans Day in honor of the service and sacrifice of veterans throughout the history of the Nation." That time is 2:11 p.m. November 11, and I would like you to share in that two minutes with me.

The holidays are upon us, and now is a time for giving. I encourage people to donate their unused clothes and coats to those in need. Volunteer at a local food pantry. Donate books to a book drive. You can't spell community without "unity."
