#### What is an open burn?

According to the International
Fire Code, an open burn is "the
burning of materials wherein
products of combustion are
emitted directly into the ambient
air without passing through a stack
or chimney from an enclosed
chamber. Open burning does not
include road flares, smudgepots
and similar devices associated
with safety or occupational uses
typically considered open flames
or recreational fires."

# OPEN BURN REQUIREMENTS



## It is the responsibility of residents, visitors and anyone doing business in Richland County to be knowledgeable of open burn requirements that help reduce fire risks.

### A \*summary of Richland County's Burn Ordinance

**Sec. 10-1, Compliance.** No one may kindle, maintain or authorize open burning within unincorporated areas of the County, except as stated.

Sec. 10-2, Location of residential yard debris burning. Open burning of leaves, tree branches and yard trimmings is permitted within \*rural zoning districts if the fire is at least 75 feet from any structure, road or property line. Open burning of leaves, tree branches and yard trimmings is prohibited in \*residential districts.

Sec. 10-3, Open burning in undeveloped areas for the purpose of land clearing or right-of-way maintenance. Open burning in undeveloped areas, including undeveloped areas in \*residential zoning districts for the purpose of land-clearing or right-of-way maintenance, is permitted if the burning is conducted within SCDHEC regulations.

Open burning for the purpose of land clearing and right-of-way maintenance is prohibited during ozone season (April 1-Oct. 30).

Sec. 10-4, Attendant and fire extinguishing equipment required; notice to state forester; adherence to state law. Burning must be constantly attended by a competent person until the fire is extinguished, with a water supply or fire extinguishing equipment readily available.

Proper notification must be given to the state forester. The notice shall contain all information required by the state forester. The burning must be conducted within state laws and regulations.

Sec. 10-5, Fires shall be prohibited as follows. The County Fire Marshal may prohibit open burning when atmospheric conditions or other conditions make fires hazardous.

The following materials are prohibited to be burned in an open fire: asphalt/asphalt materials, paint, plastics, metals, treated wood, paper, petroleum products, demolition debris, dead animals, construction debris, household chemicals, household garbage, tires, trade waste and cardboard.

**Sec. 10-6. Criteria for determining hazards.** County Council can assist in determining when fires are hazardous.

Sec. 10-7. Prohibited on County roads, drainage rights-of-way and adjacent areas. Open burning is prohibited on all County roads and drainage rights-of-way.

Sec. 10-8. Exemptions.

·Vegetative burning for forestry, wildlife and agricultural burns, as authorized by the S.C. Forestry Commission.

Open burning for the preparation of food for immediate consumption, or campfires and fires used solely for recreational purposes, ceremonial occasions or human warmth.

Sec. 10-9. Restrictions; exceptions.

Smoke production must end and no combustible material may be added to the fire between sunset of one day and sunrise of the next day.

Items not addressed within the ordinance will be enforced by governing fire codes. The Fire Marshal is authorized to order the extinguishment of open burning.

**Sec. 10-10. Hazardous or toxic materials.** The burning of hazardous or toxic materials is not permitted.
