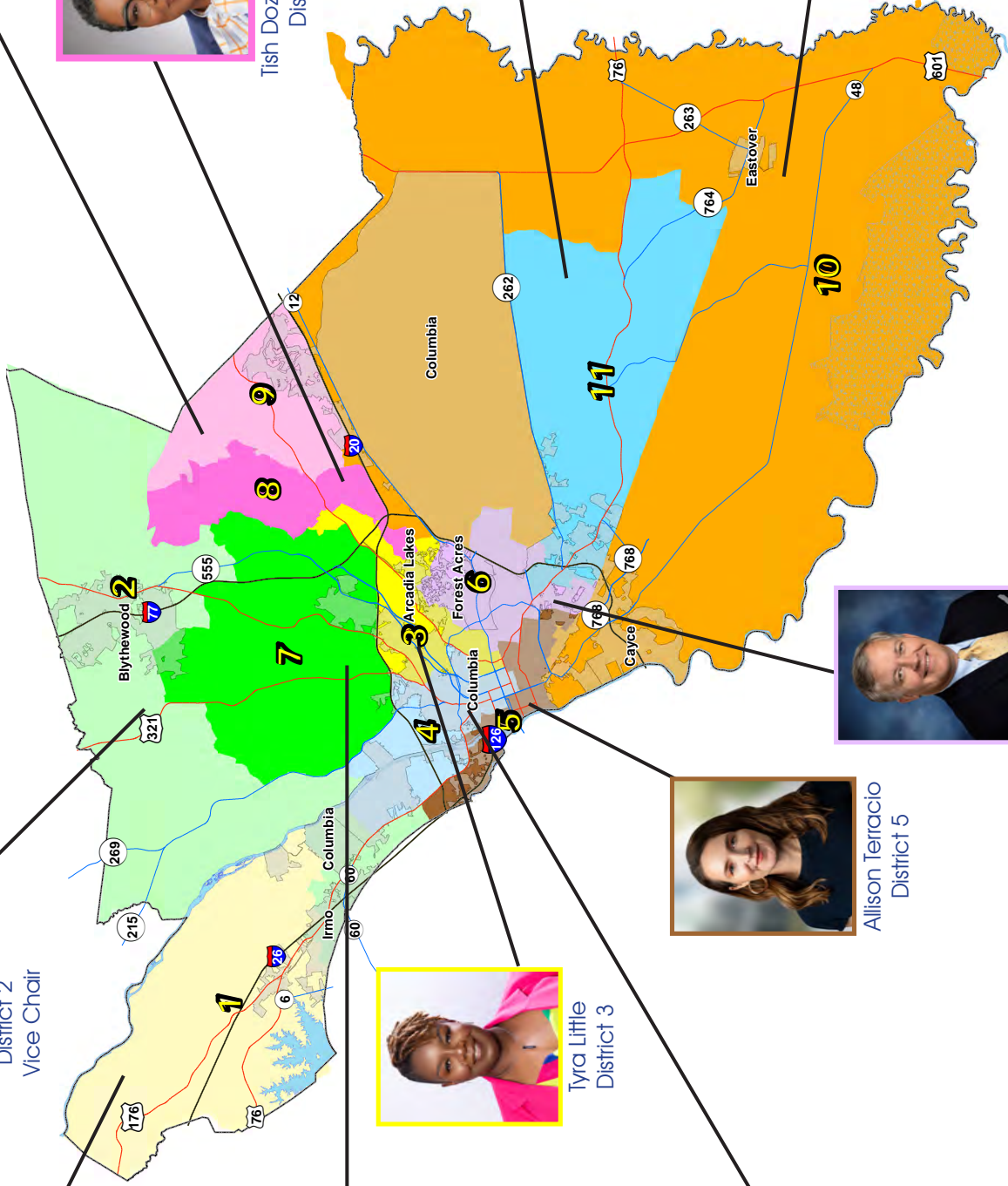

1. **CALL TO ORDER** – Chairwoman Jessica Mackey called the meeting to order at approximately 3:03 PM.
2. **APPROVAL OF MINUTES**
  - a. **March 18, 2025** – Mr. Livingston moved to approve the minutes as distributed, seconded by Ms. Mackey.  
In Favor: Pugh, Livingston, Barron, and Mackey  
Not Present: English  
The vote in favor was unanimous.
3. **ADOPTION OF AGENDA** – Ms. Barron moved to adopt the agenda as published, seconded by Mr. Pugh.  
In Favor: Pugh, Livingston, Barron, and Mackey  
Not Present: English  
The vote in favor was unanimous.
4. **ITEMS FOR DISCUSSION/ ACTION**
  - a. **Review of Allocations** – Ms. Mackey stated when the Community Impact Grants Committee was established, we agreed to set aside one mill each year for Community Impact Grants. This year, there are many budget constraints, including cuts from the Federal level that may impact County operations. She noted the Senate is discussing the budget at the State House, and we are anticipating cuts from earmarks that will have a trickle-down effect on County government.  
  
Ms. Mackey moved to set aside 10% of the total Community Impact Grants funding for child welfare issues that the County needs to address, seconded by Mr. Pugh.  
  
Ms. Barron acknowledged that we are in difficult times regarding non-profits, local government, and businesses. She recognized that the county has to address issues related to child welfare. This is a double-edged sword; while we address one area, another area still needs those same resources. She inquired if the 10% would come from the total allocation or the Community Partners portion. In addition, how did we decide on the 10%?  
  
Ms. Mackey indicated her motion is for 10% of the total Community Impact Grants allocation.  
  
Assistant County Administrator Lori Thomas stated the total amount of Community Impact Grants is \$1.764 million. The 10% would equate to \$176,400, leaving \$952,560 for the Community Partners and \$635,040 for the Competitive Grants.  
  
Mr. Pugh inquired what happens to the set-aside funds if they are not utilized.  
  
Ms. Mackey replied the Committee could reallocate the funds, or they could be returned to the General Fund.  
  
Ms. Newton expressed that she would support increasing the reserve funding set aside.

Mr. Pugh requested the breakdown of funding if they were to approve a 15% set aside.

For the record, Ms. Barron stated that she is not opposing the motion but trying to digest the matter.

Ms. Thomas responded if 15% were set aside, \$793,800 would be allocated for the Community Partners.

Ms. Barron inquired if the 10% set aside will go with the “package” forwarded to Council.

Ms. Mackey replied the award recommendations will go to Council and then be forwarded to the budget process.

Ms. Barron stated, for clarification, that when we begin to allocate funding, it will be based upon the number once the 10% has been set aside.

Mr. Pugh offered a friendly amendment to set aside 15%, and the remainder of the unused funds would stay within the committee to be dispersed among the grantees.

Ms. Mackey did not accept the friendly amendment.

Mr. Livingston called for the question, seconded by Mr. Pugh.

The vote in favor was unanimous.

The vote was unanimous to set aside 10% of the total Community Impact Grants funding.

b. FY 2026 Grant Requests

Ms. Newton inquired if the Committee had adopted guidelines related to the percentage of an organization’s overall budget that can be requested.

Ms. Maddison Wilkerson, Budget Director, indicated that the request cannot exceed 50% of their budget.

Ms. Newton would like the County to play a supportive role in the future.

Mr. Livingston moved to allocate \$470,546 to Senior Resources, seconded by Ms. Barron.

Ms. English moved to allocate \$90,000 to the Columbia Urban League, seconded by Ms. Barron.

The vote in favor was unanimous.

Ms. Barron moved to allocate \$50,000 to the Greater Columbia Community Relations Council, seconded by Ms. Mackey.

In Favor: Pugh, Livingston, Barron, Mackey, and English

The vote in favor was unanimous.

Ms. Barron moved to allocate \$53,500 to the Greater Columbia Chamber of Commerce, seconded by Mr. Livingston.

In Favor: Pugh, Livingston, Barron, Mackey, and English

The vote in favor was unanimous.

Mr. Livingston moved to allocate \$150,000 to the Midlands Housing Alliance, seconded by Ms. Barron.

In Favor: Pugh, Livingston, Barron, Mackey, and English

The vote in favor was unanimous.

Ms. Mackey moved to allocate \$125,000 to the Mental Illness Recovery Center, Inc., seconded by Ms. Barron.

In Favor: Pugh, Livingston, Barron, Mackey, and English

The vote in favor was unanimous.

Ms. Wilkerson indicated the unallocated amount balance in Community Partners funding is \$13,514.

### **COMPETITIVE GRANTS**

Mr. Pugh moved to fund SC UpLift Community Outreach at \$50,000, seconded by Ms. Mackey.

In Favor: Pugh, Livingston, Barron, Mackey, and English

The vote in favor was unanimous.

Ms. Barron moved to fund Wiley Kennedy Foundation at \$50,000, seconded by Ms. English.

In Favor: Pugh, Livingston, Barron, Mackey, and English

The vote in favor was unanimous.

Ms. English moved to fund Latino Communication CDC at \$50,000, seconded by Ms. Mackey.

In Favor: Pugh, Livingston, Barron, Mackey, and English

The vote in favor was unanimous.

Ms. Barron moved to fund The RAM Foundation at \$20,000, seconded by Ms. Mackey.

There was a discussion about whether The RAM Foundation is tied to Columbia International University.

Mr. Pugh moved to fund Range Fore Hope Foundation at \$10,000, seconded by Ms. Barron.

Mr. Livingston moved to fund Communities in Schools of South Carolina at \$25,000, seconded by Ms. Barron.

Ms. English moved to fund Able South Carolina at \$20,000, seconded by Mr. Livingston.

In Favor: Pugh, Livingston, Barron, Mackey, and English

Ms. English moved to fund the United Way of the Midlands at \$40,000, seconded by Ms. Mackey.

In Favor: Barron, Mackey, and English

Ms. Barron moved to fund the Central Midlands Development Corporation at \$20,000, seconded by Mr. Livingston.

In Favor: Pugh, Livingston, Barron, and English

The vote was in favor.

Ms. Barron moved to fund Girls on the Run (GOTR) Columbia at \$20,000, seconded by Mr. Pugh.

In Favor: Pugh, Barron, Mackey, and English

The vote was in favor.

Ms. English moved to fund Feonix – Mobility Rising at \$40,000, seconded by Mr. Pugh.

In Favor: Pugh, Livingston, Barron, Mackey, and English

The vote in favor was unanimous.

Mr. Livingston moved to reserve the balance of \$115,040 for later adjustments, seconded by Ms. English.

Ms. Barron indicated she would prefer to keep the document in committee and continue the discussion at a future meeting rather than hold the remaining funding.

Ms. Barron made a friendly amendment to keep the document in committee for further discussion and allocations at the next Community Impact Grant Committee meeting.

Mr. Livingston reiterated that he did not want to restart the discussion and allocations at the next meeting.

In Favor: Pugh, Livingston, Barron, Mackey, and English

The vote in favor was unanimous.

Ms. Mackey inquired if action was taken on all the Community Partner requests.

Ms. Wilkerson responded that no action was taken on Pathways to Healing and the Oliver Gospel Mission.

Ms. Mackey stated she is not recommending funding approval for the Oliver Gospel Mission because the organization is currently non-compliant.

For clarification, Ms. Terracio inquired if an allocation could be made by this Committee or by Council during the budget process.

Ms. Mackey stated if anyone wants to make adjustments, they will have an opportunity when it gets to Council. She requested that staff provide an updated document before the next committee meeting.

- c. Next Steps—Ms. Mackey indicated that the next step is to schedule an additional meeting to continue discussing the funding requests.
