1. **<u>CALL TO ORDER</u>** – Chairwoman Gretchen Barron called the meeting to order at approximately 3:00 PM.

2. APPROVAL OF MINUTES

a. <u>May 13, 2025</u> – Ms. Terracio moved to approve the minutes as distributed, seconded by Ms. Little.

– Ms. Terracio moved to re-appoint Tanya Rodriguez-Hodges, appoint Jessica Carswell and Joseph "Tripp" Roche to fill the Restaurant Industry vacancies, and re-advertise the remaining vacancies.
