Candidate Filing Period:

A special candidate filing period for Richland School District One At-Large will open at noon on Friday, August 20, 2021, and close at noon on Monday, August 30, 2021. Residents who are qualified electors desiring to be a candidate must file a Statement of Candidacy during this period at the Voter Registration and Elections Office of Richland County, located at 2020 Hampton St. Columbia, SC 29204.

Filing Form: The Statement of Intention of Candidacy (Nonpartisan) form required for filing is available in the "Candidate Information" section of scVOTES.gov and at the Voter Registration and Elections Office of Richland County.

State Ethics Filings: Candidates are required to file a Statement of Economic Interests and a Campaign Disclosure online with the State Ethics Commission at <http://ethics.sc.gov>. Failure to file these documents may result in a candidate fine but will not disqualify a candidate from the election. Contact the State Ethics Commission for more information.

Notice of Election:

At the close of filing, an election will be held on Tuesday, October 26, 2021. The last day to register to vote in person for this election is Friday, September 24, 2021 at 5:00 p.m. EST. Voter registration online, by fax or email must be received by 11:59 p.m. EST, Sunday September 26, 2021. Voter registration by mail must be postmarked no later than Monday, September 27, 2021. To register to vote or obtain an absentee ballot, visit the Voter Registration and Elections Office of Richland County at 2020 Hampton Street, Columbia, SC 29204 or call 803-576-2240 to request an absentee ballot by phone.

Public testing for voting machines will be held at the Voter Registration and Elections Office on Friday, September 24, 2021 at 9:00 a.m. In-person absentee voting will begin Monday, September 27, 2021 at 8:30 a.m. at 2020 Hampton Street, Columbia, SC 29204 and ends at 5:00 p.m. on Monday, October 25, 2021.

At 9:00 a.m. on October 26, 2021, the Board of Voter Registration and Elections of Richland County will begin its examination of the absentee ballot return envelopes at the Richland County Administration Building, 2020 Hampton Street, Columbia, SC 29204 in the Fourth Floor Conference Room. If you have any questions, please call 803-576-2240. The results of the election shall be determined according to the plurality method.

The Richland County Board of Voter Registration and Elections will hold a hearing to determine the validity of all provisional ballots cast in the election and to certify the results of the election at noon on Friday, October 29, 2021 at the Richland County Administration Building, 2020 Hampton Street, Columbia, SC 29204 in the Fourth Floor Conference Room.
