- Bitternut Drive (S-1317)
 - Near the City of Columbia pumping station. There are a multiple of potholes in the roadway these deep potholes have been “fixed “before and they reoccur almost instantly
 - The intersection of Starling, Goodson, and Bitternut Drive where the City of Columbia pumping station is located. Neighbors are asking for a roundabout for traffic control.
 - Potholes on bitter nut Drive. Patches have been routinely made, and they last until the first rain.
 - Speed humps on Bitternut drive and Mockernut Lane
- The tunnel that leads under interstate 77 is in desperate need of reflective paint
- Intersection improvement at Old Hopkins (S-222) and Trotter.
- Request intersection improvement due to traffic at Caughman (S-404) and Trotter.
- Sidewalks extending from Chandler Hall subdivision to Caughman Park and on Rabbit Run to Lower Richland high school.
- Speed controls or improvement of Garners Ferry Road (near Aldi. There have been several fatalities there over the years.
- Water ponding at the corner of Garners Ferry Road and Hazelwood Drive
